Bookings made by telephone will be held for one week from the date of enquiry. **No booking will be confirmed until this form has been returned, signed , completed and full boarding fees paid. Only fully vaccinated cats will be accepted.**

No responsibility is taken for loss, escape or sickness of any cat whilst at the cattery, or during the transport to and from there. Nor for any of the owner's property which is brought with the cat(s). In the event of any cat becoming ill, treatment will be charged for. All boarding fees and expenses which may arise must be paid in advance. Any extra services will be priced separately and added to the final account. In the event of any cat not being collected and the boarding fees due not being paid within 14 days of the due date of collection, the cats(s) will be considered as abandoned I also consent that whenever necessary I agree to my pet/pets being examined and treated by a veterinary surgeon.

CATS ARE ACCEPTED FOR BOARDING ONLY AT OWNERS RISK.

Please note: Day of arrival and departure will be charged for.

Churchwoods Cat Hotel may refuse to board any animal which is not suitable for boarding.

FEES. All fees are charged by the day, to include the day of arrival and the day of departure.. Fees are payable upon completion of this booking form. **The total fees for the agreed amount must be paid in full even if your pet is collected early. This reservation will be held for 1 week and then cancelled if payment is not received in full. Boarding fees may only be made in cash. Unfortunately once the fees are paid there can be NO REFUNDS or CREDIT NOTES given.**

VACCINATIONS. All pets accepted for boarding must be accompanied by a current **Vaccination Certificate.** Rabies. Also, Feline Rhinotracheitis, Calicivirus & Panleukopnia – first time vaccinations must be at least 14 days old. All pets will receive Frontline –anti flea and tick treatment or an alternative upon arrival.

VETS FEES. If the Kennels are liable for the vets fees the fees will be paid direct. If this is not the case any Veterinary fees incurred during the boarding period may be billed directly to you by your vet, or sometimes, may be billed by our vet if for some reason it is not possible to use your vet, but is the responsibility of the client and must be paid at the time of settling the boarding fees. Should your pet become ill and need veterinary care we shall endeavour to take him/her to your nominated veterinary clinic at a charge of 200Dhs. We will then invoice you for the vet’s charges at the end of your pet’s stay.

BELONGINGS. We supply beds and bedding but we cannot guarantee the safe return of any toys that might accompany your pet, all belongings left on the premises are left entirely at the clients risk. All toys must be clearly marked with the clients name and the pets. *20% discount will be given for every extra cat sharing a kennel.* Every care will be given to the welfare and safety of all pets boarded, but all pets are boarded entirely at the clients risk. If your pet passes away whilst in our care, we will do our utmost to have the body frozen so that you can make any decisions on your return, as to Cremation, Burial and Post Mortems. Unfortunately, the cost if any will have to be added to your bill.

If I fail to collect my pet/pets within 14 days of the due date of collection, I give the owner of the above business the authority to re home or dispose of my pets without further reference to me, provided that I have not made arrangements over the telephone or in writing for the boarding period to be extended.

I undertake to abide by these terms and conditions on every occasion my pet/pets is/are boarded on these premises. I consent that whenever necessary I agree to my pet/pets being examined and treated by a veterinary surgeon.
